## What's the Quality of My Water?

The Village of New Bremen has prepared the following water quality report for you. It describes to you, the customer, the quality of your drinking water. Included within this report is general health information, water quality test results, how to participate in decisions concerning your drinking water and water system contacts. This report covers January 1 through December 31, 2021. The Village of New Bremen's drinking water supply surpassed the strict regulations of both the State of Ohio and the U.S. Environmental Protection Agency (EPA), which requires all water suppliers to prepare reports like this every year.

In 2021 our water department distributed 114 million gallons of water to our customers. Our water source is groundwater pumped from a series of six deep wells. Wells 1, 2, and 3 are located on the water plant property. Well 7 is located on the Isern farm south of Amsterdam Road. Wells 9 and 10 are located on the old Hehr farm north west of the village.

New Bremen treats your water using induced draft aeration, pressure filtration, ion exchange softening, and disinfection to remove or reduce harmful contaminants that may come from the source water.

Ohio EPA recently completed a study of the Village of New Bremen's source of drinking water to identify potential contaminant sources and provide guidance on protecting drinking water source. According to this study, the aquifer (water rich zone) that supplies water to the Village of New Bremen has a low susceptibility to contamination. This determination is based on the following:

- presence of a thick protective layer of clay overlying the aquifer
- significant depth (over 65 feet below ground surface) of the aquifer

This susceptibility means that under current existing conditions, the likelihood of the aquifer becoming contaminated is relatively low. Implementing appropriate protective measures can minimize this likelihood. ## The U.S. Environmental Protection Agency (EPA) wants you to know:

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

### Contaminants that may be present in source water include:

**Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

**Inorganic contaminants**, such as salts and metals which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

**Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

**Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

**Radioactive contaminants**, which can be naturally occurring or be the result of oil and gas production and mining activities.

2021 Village of New Bremen's Results of Monitoring for Contaminants in Drinking Water								
<b>Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. In 2021 in accordance with EPA requirements, the Village of New Bremen did testing for the possibility of contaminants in its water supply. Included in this report are the contaminants that we detected in the water, none of which are a violation or a health risk in such minute traces.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of New Bremen is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ### Footnotes:

- <sup>1</sup>The state allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.
- <sup>2</sup>Copper is measured at the customer's tap.
- <sup>3</sup>Fluoride naturally occurs in well water used by the Village of New Bremen.

### Definitions:

**Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Maximum Residual Disinfectant Level Goal (MRDLG):** The level of residual disinfectant below which there is no known or expect risk to health.

**Maximum Residual Disinfectant Level Goal (MRDL):** The level of a drinking water disinfectant below which there is no known or expected risk to health.

**Action Level (AL):** The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements, which a water system must follow.

**90th Percentile:** 90% of samples are equal to or less than the number in the chart.

**The "<" Symbol:** A symbol which means 'less than'. A result of "<5" means that the lowest level detected was 5 and the contaminant in that sample was not detected.

**NA:** Not applicable.

**ND:** Not detectable at testing limits.

**PPB (parts per billion)** are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

**PPM (parts per million)** are units of measure for concentration of a contaminant. A part per million corresponds to one second in 11.5 days.

**HQA:** Highest Quarterly Average.

**CDC:** Centers for Disease Control.

**EPA:** Environmental Protection Agency.

**The Village of New Bremen has a current, unconditional license to operate the water system.**

## DRINKING WATER NOTICE

### Monitoring requirements were not met for NEW BREMEN VILLAGE

*We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During December 2020, we “did not monitor or test” or “did not complete all monitoring or testing” for total coliform bacteria, and therefore, cannot be sure of the quality of your drinking water during that time.*

#### What should I do?

- There is nothing you need to do at this time. **You do not need to boil your water or take other corrective actions.**
- This notice is to inform you that NEW BREMEN VILLAGE did not monitor, and report results for the presence of total coliform bacteria in the public drinking water system during the December 2020 time period, as required by the Ohio Environmental Protection Agency.

#### What is being done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.
